
Notes on Contributors

Nir Arielli is a Lecturer in History at the University of Worcester. He is author of *Fascist Italy and the Middle East* (Basingstoke, 2010) and is currently conducting comparative research on transnational war volunteers in modern conflicts.

Laurence Badel is professor of international relations at the University of Strasbourg (France), and a member of the Institut universitaire de France. She teaches the history of twentieth-century European integration. She also leads two research groups, one on new diplomatic practices in Europe (19th to 21st centuries), and the other on European management and the interaction between regionalisation and globalisation. Her recent publications include *Diplomatie et grands contrats: L'Etat français et les marchés extérieurs au XXe siècle* (Paris, 2010) and, co-edited with Eric Buissonière, *François-Xavier Ortoli: L'Europe, quel numéro de téléphone?* (Paris, 2011).

Francesca Fauri is a professor of European Economic History at the Faculty of Political Sciences (Forlì Campus), University of Bologna. She has published extensively on issues concerning the history of European economic integration and Italy's postwar economic and business history – her most recent work is a co-edited a book on European re-industrialization after World War II, *New Outlooks on the Marshall Plan* (Bruxelles, Bern, et al., 2011). She is affiliated to the Department of Economics of the University of Bologna and is a member of the scientific committee of the Punto Europa in Forlì.

Stephen G. Gross is a lecturer in the International and Area Studies programme at UC Berkeley, where he teaches courses on political economy, nationalism, and economic history. He received a PhD from Berkeley in 2010 in modern European history. His scholarship examines questions of political economy in German history, ranging from war finance to trade relations, and has appeared in journals such as *Central European History*. He is currently writing a book on the soft power of German economic and cultural diplomacy in south-eastern Europe during the 1920s and 1930s, which shows how German businessmen aggressively sought to forge a federative European economic bloc during both the Weimar Republic and the early years of the Third Reich.

Christian Haase is Lecturer in Modern German History at the University of Nottingham. He has published on foreign policy and media history in the twentieth century and is currently finalising his research on the life of Countess Marion Dönhoff, who moulded the memorialization of the resistance of 20 July 1944 in Germany and beyond. His most recent publications include Christian Haase and Axel Schildt (eds.), *'DIE ZEIT' und die Bonner Republik: Eine meinungsbildende Wochenzeitung zwischen Wiederbewaffnung und Wiedervereinigung* (Göttingen, 2008); and Christian Haase, *Pragmatic Peacemakers: Institutes of International Affairs and the Liberalization of West Germany* (Augsburg, 2007).

Christian Kraiker is writing his PhD on the West German press and transatlantic relations during the chancellorship of Helmut Schmidt. The PhD is supervised by Christian Haase.

Jörn Kreuzer has been working as research assistant on the project 'Press and Politics in West Germany: The Personal Papers of Countess Dönhoff'. The project is led by Christian Haase.

Devin O. Pendas is Associate Professor of History at Boston College. He is the author of *The Frankfurt Auschwitz Trial, 1963–1965: Genocide, History, and the Limits of the Law* (2006), as well as numerous articles on the history of Holocaust trials, international law, and human rights.

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor Amir Weiner, weiner@stanford.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short description of work in progress and previously published work
