Tom Buchanan is Reader in Modern History and Politics at the University of Oxford's Department for Continuing Education. He has published three books on British involvement in the Spanish Civil War, and his book *East Wind: China and the British Left, 1925–1976* will be published by Oxford University Press in 2012. A second edition of his book *Europe's Troubled Peace: 1945 to the Present* was recently published by Wiley-Blackwell. He is currently researching a book on political imprisonment and the rise of the human rights movement since 1945.

Karrin Hanshew is associate professor of history at Michigan State University. Her book, *Terror and Democracy in West Germany*, appeared in 2012 with Cambridge University Press and her new project is tentatively entitled *Germans in Italy: A (European) Love Affair*.

Klaus Petersen is Professor of Welfare History and Director of the Centre for Welfare State Research at the University of Southern Denmark. Research interests include welfare state history and Nordic political history. He is currently co-editing a six-volume Danish Welfare History (sponsored by the Carlsberg Foundation), directing a project on concepts and language of the welfare state (The Danish Council for Independent Research/Humanities) and is vice-director of the Nordic Centre of Excellence NordWel (sponsored by NordForsk).

Nico Pizzolato is Lecturer in History at Queen Mary, University of London. His research interests focus on the interplay of race, ethnicity and culture in social and political movements. His publications include numerous articles in leading peer-reviewed journals in which he has explored the themes of political identity, protest, and social representation of African-Americans and Italian southern migrants in the postwar period, using a transnational and comparative approach. His publications include 'Transnational Radicals: Labour Dissent and Political Activism in Detroit and Turin (1950–1970)', *International Review of Social History*, 56, (2011), 1–30; 'Revolution in a Comic Strip: Gasparazzo and the Identity of Southern Migrants in Turin (1969–1975)', *International Review of Social History*, 52, Suppl. 15 (2007); 'Gli operai, gli immigrati, la rivoluzione. Detroit e Torino: un'ipotesi comparativa (1967–1973)', *Meridiana*, 56 (2007); 'Workers and Revolutionaries at the Twilight of Fordism', *Labor History*, 45 (2004), 419–43.

Nils Arne Sørensen is Professor of Contemporary History at University of Southern Denmark. Previous research interests have included fascism, identity politics, World War One and the social and cultural history of the Cold War. Since 2008 he has directed a research project on Americanisation processes in Denmark, sponsored by The Danish Council for Independent Research/Humanities.

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor Amir Weiner, weiner@stanford.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be referred

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

- 1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear

- 4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
- 5. a short biographical note with a description of work in progress and previously published work (130 words max.)
