Andrea Acle-Kreysing is a postdoctoral fellow at the Alexander von Humboldt Foundation (Germany). Her research project is entitled ‘Anti-Fascist Exile in Mexico City and Buenos Aires: The Construction of a Transatlantic Political Culture (1930s–1940s)’ and is currently being developed within both Historicum (Ludwig Maximilian University Munich) and the Global and European Studies Institute (University of Leipzig). She holds a BA degree from El Colegio de México (2000–2004), as well as MPhil and PhD degrees from the University of Cambridge (2006–2011). Her doctoral dissertation is entitled *Rethinking Conservatism in Nineteenth-Century Spain: The Cases of Jaime Balmes (1810–1848) and Juan Donoso Cortés (1809–1853)* and will soon be published as a monograph. She has also written on Mexican history, exploring both nineteenth-century political thought (*Historia Mexicana*, 2011) and the development of a distinctive anti-fascist political culture in the figure of labour leader Vicente Lombardo Toledano in the 1930s and 1940s (*Revista de Indias*, forthcoming).

Claudia Baldoli is Senior Lecturer in European History at Newcastle University (UK). Her publications include *Exporting Fascism: Italian Fascists and Britain’s Italians in the 1930s* (Berg, 2003), *A History of Italy* (Palgrave, 2009) and, with A. Knapp, *Forgotten Blitzes: France and Italy under Allied Air Attack, 1940–1945* (Continuum, 2012). She has recently published a critical edition, with B. Fleming, of *A British Fascist in the Second World War: The Italian War Diary of James Strachey Barnes, 1943–1945* (Bloomsbury, 2014).

Kasper Braskén is a postdoctoral researcher at Åbo Akademi University (Turku, Finland). He is a historian specialising in German, transnational and social movement history. He is the co-editor of *H-Socialisms* and the author of several articles on international solidarity, communism and anti-fascism. His postdoctoral project ‘The Origins of Anti-Fascism: Transnational Movements against Fascism, Nazism and the White Terror in Europe, 1923–1939’ is funded by the Kone Foundation (2014–2016). Braskén has done extensive archival research on the interwar international communist and socialist movement in Moscow, Berlin, Bonn, Amsterdam, London and Manchester. He has been Visiting Scholar at the Zentrum für Zeithistorische

Forschung (Potsdam), Freie Universität Berlin and Royal Holloway (London). He is author of *The International Workers' Relief, Communism, and Transnational Solidarity: Willi Münzenberg in Weimar Germany* (Palgrave Macmillan, 2015).

Tom Buchanan is Professor of Modern British and European History at Oxford University's Department for Continuing Education, where he is Director of Studies in History and Politics. He has published three books and numerous articles on the relationship between Britain and the Spanish Civil War. His most recent book is *East Wind: China and the British Left, 1925–1976* (2012). He is currently working on a book on Amnesty International and the emergence of human rights activism in post-war Britain for Cambridge University Press.

Nigel Copsey is Professor of Modern History and Co-Director of the Centre for Fascist, Anti-Fascist and Post-Fascist Studies at Teesside University (UK). He has published extensively on right-wing extremism and its opposition. He is author of *Anti-Fascism in Britain* (2000, 2nd edn. forthcoming) and *Contemporary British Fascism: The British National Party and the Quest for Legitimacy* (2004, 2nd edn. 2008). He is also co-editor of four books on British fascism and anti-fascism. His latest co-edited book is *Cultures of Post-War British Fascism* (2015).

Hugo García is Associate Professor of Modern History at the Universidad Autónoma de Madrid (Spain). He is author of *The Truth about Spain! Mobilizing British Public Opinion, 1936–1939* (Sussex Academic Press, 2010) and co-editor of *Rethinking Antifascism: History, Memory, and Politics, 1922–1945* (Berghahn, 2016). He has also published a number of articles on propaganda, political cultures, social movements and literature in interwar Europe, including 'Potemkin in Spain? British Unofficial Missions of Investigation to Spain during the Civil War' (*European History Quarterly*, 2010) and 'Barbarians, Telescreens, and Jazz: Reactionary Uchronias in Modern Spain, ca. 1870–1960' (*Utopian Studies*, 2015).

Xosé M. Núñez Seixas obtained his PhD at the European University Institute in Florence and is currently Full Professor of Modern History at the University of Santiago de Compostela. Since October 2012 he is also Full Professor of Modern European History at the Ludwig-Maximilian University, Munich. He has been Visiting Scholar at the Universities of Bielefeld, Freiburg, Paris X, Paris VII, Rennes, City University of New York and Stanford. His work focuses on the comparative history of nationalist movements and national and regional identities, as well as on the analysis of overseas migration from Spain and Galicia to Latin America and the study of modern war and war experiences in the twentieth century. Among his most recent books, are *¡Fuera el invasor! Nacionalismo y movilización bélica en la guerra civil española 1936–1939* (Marcial Pons, 2006); *Patriotas y demócratas. El discurso nacionalista español después de Franco* (Catarata, 2010); edited with J. Moreno, *Ser españoles. Imaginarios nacionalistas en el siglo XX* (RBA, 2013) and *Die spanische Blaue Division an der Ostfront, 1941–1945. Zwischen Kriegserfahrung und Erinnerung* (Aschendorff, 2016).

Jens Späth holds a PhD from Ludwig-Maximilians University, Munich. He has worked as a Research Fellow at the German Historical Institute in Rome and is now Lecturer in Modern European History at Saarland University in Germany and at the Franco-German campus of Sciences Po in Nancy. His main research interests are the political, constitutional and cultural histories of Italy, Spain, France and Germany in a comparative and transnational perspective. He is the author of a monograph on the first revolutions after the fall of Napoleon in Southern Europe entitled *Revolution in Europa 1820–1823. Verfassung und Verfassungskultur in den Königreichen Spanien, beider Sizilien und Sardinien-Piemont* (Sh-Verlag, 2012) and co-editor of a volume on the 150th anniversary of Italian unity called *150 Jahre Risorgimento – geeintes Italien?* (Kliomedica, 2014). Currently he is working on socialist anti-fascism in France, Italy and Germany. He has presented some of his findings concerning the Italian case in his article ‘Was heißt Antifaschismus nach 1945? Das Beispiel der italienischen Sozialisten in westeuropäischer Perspektive’ (*Archiv für Sozialgeschichte*, 2013).

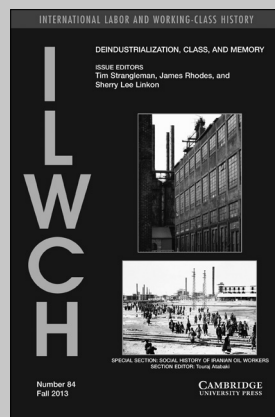

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Authors wishing to submit articles for publication should do so through the journal's online submissions system at <http://mc.manuscriptcentral.com/conteurohistory>.

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers will be expected to submit a final version which should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short biographical note with a description of work in progress and previously published work (130 words max.)
