Peter Anderson is a British Academy Postdoctoral Fellow in the Department of International History and the Cañada Blanch Centre for Contemporary Spanish Studies at the London School of Economics. He is currently working on a monograph on the Françoist repression in Spain between 1939 and 1945.

Richard Bosworth currently holds joint chairs at the University of Western Australia and Reading University. His last three books have been *Mussolini* (2002), *Mussolini's Italy* (2006) and *Nationalism* (2007), and he is presently working on a book for Yale University Press, to be entitled *Rome and its Histories* 1800–2000.

Thomas Fetzer is Marie Curie Post-doctoral Fellow in the Department of Employment Relations, London School of Economics. Among his recent publications are 'Turning Eurosceptic: British Trade Unions and European Integration (1961–1975)', in the *Journal of European Integration History* (2007), and 'Cross-border Trade Union Co-operation in European Works Councils: The case of General Motors', in the *European Journal of Industrial Relations* (forthcoming).

Gesine Gerhard is an associate professor of history at the University of the Pacific in California. She received her Ph.D. from the University of Iowa in 2000 and also has an M.A. from the Technical University Berlin. Her research interests include environmental and agrarian history and her current projects include a biography of Herbert Backe and a study of the transmission of memory in the families of Nazi perpetrators. A recent piece on Richard Walther Darré's agrarian ideology is published in *How Green Were the Nazis? Nature, Environment, and Nation in the Third Reich*, edited by Franz-Josef Brüggemeier, Mark Cioc and Thomas Zeller (2005).

Till Kössler teaches in the Department of Contemporary History, Ludwig-Maximilians University. He is the author of *Abschied von der Revolution. Kommunisten und Gesellschaft in Westdeutschland*, 1945–1968 (2005) and co-editor of *Vom Funktionieren der Funktionäre. Politische Interessenvertretung und gesellschaftliche Integration in Deutschland nach 1933* (2004), and has also published widely on the history of left-wing political parties and labour relations in twentieth-century Germany. He is currently completing a study on childhood and modernity in Spain, 1900–39.

Alexis Spire is research fellow at France's Centre National de la Récherche Scientifique (CNRS), currently associated with the Centre d'études et de recherches

administratives politiques et sociales (CERAPS), University of Lille 2. His research has centred on the politics of immigration control, in particular on the role of the street-level bureaucrats. He has published a number of articles on this subject and a book *Etrangers à la carte* (2005).

Philip Whalen is an associate professor of history at Coastal Carolina University. His research investigates the way in which Burgundian gastronomy, tourism, festivals and folklore informed the construction of a regional model of French commercial republicanism during the inter-war period. Recent articles in the *Journal of Folklore Research* (2007) and *Annales de Bourgogne* (2008) have examined provincial governance and the transformation of regional folklore. He has also edited an interdisciplinary collection of essays, *Vins, Vignes et Gastronomie bourguignonne selon Gaston Roupnel* (2007).

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor John Connelly, jfconnell@berkeley.edu.

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

- 1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
- 2. a 100-word summary of the article in English, French or German
- 3. a short title for use as a running page-head
- 4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
- 5. a short description of work in progress and previously published work
