Ewa Berard studied at Warsaw, Paris and Yale Universities. Researcher at the French Centre National de la Recherche Scientifique, she taught at the Institut National des Langues Orientales and has directed seminars at the Ecole Normale Supérieure in Paris. Her research has focused on the impact of the nineteenth-century Slavophile-Westernizer ideology on Russia's foreign policy and on the Soviet intelligentsia involvement in cultural diplomacy, published in La vie tumultueuse d'Ilya Ehrenbourg – russe, juif et soviétique (Ramsay, 1991). While reporting on Gorbachev's perestroika for French and Polish periodicals, she approached the process of building modern society from the vintage point of urban transformation in three post-socialist countries, as seen in Architectures au-delà du mur. Moscou-Varsovie-Berlin, 1989–2009 (Picard, 2010). She developed urban studies deconstructing Leningrad-Petersburg literary myth in Pétersbourg impérial. Nicolas II, les arts et la ville (Belin, 2012). Presently she is working on the cross-history of Polish and Russian Jews 1860–1945.

Alice Byrne lectures in British Studies at Aix Marseille University. Her research explores different facets of British cultural diplomacy in the twentieth century, with an emphasis on the Second World War and the early Cold War. Her most recent publications include 'The Commonwealth University Interchange Scheme: Promoting Exchanges in a Changing World (1948–1960)', in Ludovic Tournès and Giles Scott-Smith, eds., *Global Exchanges: Scholarships and Transnational Circulations in the Modern World* (Berghahn Books, 2018) and 'Britain To-day, Bulletins from Britain and Britain: Some Semi-Official British Periodicals in the USA during World War Two', in Simon Eliot and Marc Wiggam, eds., *Allied Communication to the Public During the Second World War: National and Transnational Networks* (Bloomsbury Academic, 2019).

Nikolas Glover teaches and researches at the Department of Economic History, Uppsala University. He has published widely on the cultural history of the Swedish export economy, including studies of public diplomacy, export promotion, development aid and internationalism. He is the author of *National Relations: Public Diplomacy, National Identity and the Swedish Institute 1945–1970* (Nordic Academy Press, 2011) and the co-editor of *Histories of Public Diplomacy and Nation Branding in the Nordic and Baltic Countries: Representing the Periphery* (Brill-Nijhoff, 2015). Currently he is working on the project "The Defence of Consumption: Advertising, Gender and citizenship in Sweden during World War II', funded by the Swedish Research Council.

Andreas Mørkved Hellenes is a post-doctoral researcher at Aarhus University working on the project *Nordic Model(s) in the Global Circulation of Ideas*, 1970–2020, funded by the Independent Research Fund Denmark. He received his PhD in history at Sciences Po Paris and the University of Oslo in 2019 for his thesis *Fabricating Sweden: Studies of Swedish Public Diplomacy in France from the 1930s to the 1990s.*

Benjamin G. Martin is a graduate of the University of Chicago and Columbia University. He is Senior Lecturer in the Department of History of Science and Ideas at Uppsala University, where he is lead researcher on the project 'International Ideas at UNESCO: Digital Approaches to Global Conceptual History', funded by the Swedish Research Council (2020–2). A previous grant, from the Swedish Foundation for Humanities and Social Sciences, supported the research for this article. His publications have appeared in *The Journal of Contemporary History* and *International Politics*, as well as in several edited volumes. His book *The Nazi-Fascist New Order for European Culture* (Harvard University Press, 2016), won the 2020 Culbert Family Book Prize of the International Association for Media and History.

Luis Martinez del Campo is 'Juan de la Cierva' Research Fellow in Contemporary History at the Complutense University of Madrid. In 2014 he received a PhD (European Distinction) from the University of Zaragoza. His PhD dissertation explores the relationship between British trade with Latin America and the advocacy of Spanish language education in early twentieth-century England. Over the last years, he has held post-doctoral positions at the universities of Concepción (Chile), Essex (United Kingdom) and the Basque Country (Spain). His previous research focuses on the history of British–Spanish cultural relations in the twentieth century, but he is currently looking at the spread of Spanish language in the world as a soft power resource. He is the author of *Cultural Diplomacy: A Hundred Years of History of the British-Spanish Society* (LUP, 2015), which examines the history of a cultural institution at the heart of the relationship between Britain and the Spanish-speaking world in the twentieth century.

Zsolt Nagy is Associate Professor of History at the University of St. Thomas in Minnesota. He is the author of *Great Expectations and Interwar Realities: Hungarian Cultural Diplomacy, 1918–1941* (Central European University Press, 2017), as well as articles in *Contemporary European History* and the *Hungarian Studies Review*.

Elisabeth Marie Piller is Assistant Professor of Transatlantic and North American History at Albert-Ludwigs-Universität Freiburg, Germany. She works on US and German foreign policy and transatlantic relations in the nineteenth and twentieth centuries. Her first monograph is Selling Weimar: German Public Diplomacy and the United States, 1918–1933 (Franz Steiner, 2021). Her work has appeared in Diplomatic History, the Journal of Contemporary History and the Journal of the Gilded Age and Progressive Era, as well as in a number of edited collections. She is currently working on her second book, a study of US humanitarian aid and transatlantic relations from the 1890s to the 1970s.

Peter Polak-Springer is Associate Professor of History at Qatar University. He received his PhD from Rutgers University (New Brunswick, USA) and held research fellowships from the Fulbright Hays, the Social Science Research Council, the American Council of Learned Societies and the Berlin Program. His research interests include transnational and cultural historical and comparative approaches to borderlands, nationalism, anti-Semitism, Islamophobia and irredentism, and the history of Central Europe and the Middle East in the twentieth century. He is author of *Recovered Territory: A German-Polish Contest over Land and Culture*, 1919–1989 (Berghahn Books, 2015), as well as a number of journal articles and collection chapters on topics connected to German-Polish cultural politics in borderlands, religion and nationalism in Mandatory Palestine and interwar Poland, Syrian refugees in Germany and, more recently, Palestinian views of anti-Semitism in Eastern Europe during the 1930s.

Tara Talwar Windsor is Research Fellow in Modern Languages at the University of Birmingham, United Kingdom. She had previously held positions in the history departments at Liverpool John Moores University, Trinity College Dublin and the Bergische Universität Wuppertal. Her main research interests lie in cultural connections between modern Germany, Europe and the wider world, and in the relationship between intellectuals, civil society and the state. She is the author of several chapters on (Anglo-)German cultural relations after the First World War and is currently preparing a monograph entitled *Authors Across Borders: Weimar Writers and the International Politics of Culture.* She is also co-producing a critical reader of translated exile writings from Nazi Germany and Francoist Spain and working on a new collaborative project on literary networks in East Germany.





INSTRUCTIONS FOR CONTRIBUTORS

Contemporary European History covers the history of Eastern and Western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Authors wishing to submit articles for publication should do so through the journal's online submissions system at http://mc.manuscriptcentral.com/conteurohistory.

Articles should normally be about 8,000 words long, not including footnotes. Review articles should not exceed 6,000 words, including footnotes. The journal also considers special issue proposals. Please contact the editors for details.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be referred.

Submission of an article will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of an article, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

Contributors must keep closely to the journal's stylistic conventions. The editors will return any contribution which does not follow the conventions for correction.
